Mayor Partington stated per Florida Statute, he was required to state the final millage rate for the City of Ormond Beach necessary to fund the Fiscal Year (FY) 2022-2023 budget was 3.7610 mills. The rate was 5.68 percent above the rolled back rate of 3.5587 mills. The debt service millage rates were 0.0050 for the 2003 General Obligation Bond Sinking Fund and 0.0800 for the 2010 General Obligation Bond Sinking Fund.

Mayor Partington stated it was a public hearing and inquired if there were any members of the public who wish to speak or ask questions prior to adoption of the final millage rate and budget.

Commissioner Persis moved, seconded by Commissioner Selby, for approval of Resolution No. 2022-110, as read by title only.

Mayor Partington stated the final operating millage of 3.7610 mills was 5.68 percent above the rolled back millage rate. The resolution also included adoption of the debt service millage rates of 0.0050 for the 2003 General Obligation Bond Sinking Fund and 0.0800 for the 2010 General Obligation Bond Sinking Fund.

He stated the city’s part would be 20 percent plus \$7,000 of the closing costs totaling \$161,000, noting the city and Volusia County would own the property while SJRWMD would maintain the conservation easement.

Mayor Partington inquired if the Volusia County Council votes were unanimous; whereby, Mr. Spraker confirmed they were.

Commissioner Persis moved, seconded by Commissioner Littleton, for approval of Resolution No. 2022-117, as read by title only.

Commissioner Selby inquired how Florida Department of Transportation’s (FDOT) mitigation needs factored into the property; whereby, Mr. Spraker explained FDOT was required by SJRWMD to acquire land for preservation due to the environmental impact of a roadway project.

Item #12 – Reports, Suggestions, Requests

Compliments

Ms. Joyce Shanahan, City Manager, thanked the Commission and the Finance Department for their work on the budget.

Commissioner Selby complimented Ferritto Family Limitless Park and encouraged citizens to visit.

Commissioner Persis discussed her support of the legislative recognition.

Projects

Ms. Shanahan stated the Facility Hardening project was scheduled to be completed over the next few weeks. She stated the South Washington Street Sidewalk project was moving forward and work would begin soon, the playground at Fleming Avenue was pending the final play surface to be installed and the Water Reclamation Facility Clarifier project schedule was being finalized.

Commissioner Selby stated Ormond Beach MainStreet was discussing a project for adding lights to the palm trees.

Events

Ms. Shanahan explained National Night Out was scheduled for October 4, 2022, and the City Commission meeting normally scheduled for that day was previously rescheduled for October 5, 2022. She stated Movies on the Halifax would be on October 7, 2022, on October 8, 2022 would be the Reel in the Fun fishing tournament and State of the City would be held on October 11, 2022.

Commissioner Selby regretted to inform the Commission and staff he was unable to attend the State of the City event due to a conflicting event in Cuba.

Commissioner Kent discussed the Crime Stoppers’ event and complimented Ormond Beach candidate Detective Ryan Smith.

Commissioner Persis complimented staff and the city for the 9/11 Memorial event. She stated she attended the Tenth Anniversary event for the Ormond Beach Observer.

Commissioner Littleton encouraged citizens to prepare for potential hurricanes.

Granada Bridge and Beach Entry

Commissioner Selby voiced his concerns regarding the Granada Boulevard bridge compared to the bridge on International Speedway Boulevard in Daytona Beach. He discussed possible artistic and lighting designs, noting while FDOT was working on Granada Boulevard the city could discuss a bridge redesign. He also suggested adding an entry arch at the Granada Boulevard beach access similar to the International Speedway Boulevard beach access arch.

Commissioner Persis agreed with Commissioner Selby on the bridge and would like for the upgrades, noting she would prefer to see the bridge improvements before discussing a beach access arch.
